THE SENIOR COMMUNITY SERVICE EMPLOYMENT PROGRAM (SCSEP) IS A JOB-TRAINING PROGRAM FOR OLDER ADULTS LOCATED IN 38 OHIO COUNTIES. FUNDED UNDER GRANTS FROM THE U.S. DEPARTMENT OF LABOR AND OHIO DEPARTMENT OF AGING, THE PROGRAM PROVIDES PAID, PART-TIME JOB TRAINING IN COMMUNITY SERVICE ASSIGNMENTS. PROGRAM PARTICIPANTS ARE LOW-INCOME ADULTS AGE 55 AND OLDER PLACED WITH NONPROFIT AND GOVERNMENT AGENCIES FOR TRAINING. IN THE FISCAL YEAR 20, DUE TO THE COVID PUBLIC HEALTH EMERGENCY, VANTAGE CREATED A LEARN AND EARN PROGRAM TO MITIGATE THE RISK OF INFECTION OF THE VIRUS FOR OUR AT-RISK CLIENT POPULATION. SCSEP PARTICIPANTS WERE ENROLLED IN REMOTE, AT-HOME TRAINING WHERE PAPER/PENCIL TRAINING PACKETS WERE DELIVERED TO PARTICIPANTS' HOMES AND

MEALS ON WHEELS OF NORTHEAST OHIO IS SUPPORTING THE NUTRITIONAL NEEDS OF OLDER ADULTS IN SUMMIT, STARK AND WAYNE COUNTIES. THE MEALS ON WHEELS PROGRAM DELIVERED NUTRITIOUS MEALS TO 3,868 HOMEBOUND AND DISABLED CLIENTS TO SUPPORT THEIR HEALTH AND WELL-BEING. IN THE FISCAL YEAR 2020, WE DELIVERED 495,783 HOME DELIVERED MEALS AND PROVIDED 15,219 CONGREGATE MEALS. MEALS INCLUDED HOT, FROZEN, AND THERAPEUTIC OPTIONS. AS PART OF THE OHIO SENIOR FARMERS' MARKET NUTRITION PROGRAM, WE PROVIDED 8,330 VOUCHERS TO 833 SENIORS AGE 60 AND OLDER WHO MET INCOME GUIDELINES FOR THE PURCHASE OF UP TO \$50 IN FRESH PRODUCE AT LOCAL FARMER'S MARKETS.

BEHAVIORAL HEALTH SOLUTIONS PROVIDES PERSONALIZED COUNSELING SERVICES THAT BREAK DOWN THE BARRIERS TO RECOVERY FOR MENTAL HEALTH AND ADDICTION. OUR EXPERT TEAM FOCUSES ON A HOLISTIC APPROACH, CONNECTING PEOPLE TO ADDITIONAL SUPPORTIVE SERVICES THEY MAY NEED AND OFFERING A VARIETY OF SERVICES. SERVICES INCLUDE GROUP AND INDIVIDUAL COUNSELING, INTENSIVE OUTPATIENT, CASE MANAGEMENT, CRISIS MANAGEMENT INTERVENTION, ASSESSMENT, PEER COACHING, MENTORING, AND RECOVERY SUPPORT SERVICES.
