FUNDED UNDER GRANTS FROM THE U.S. DEPARTMENT OF LABOR (DOL), OHIO DEPARTMENT OF AGING (ODA), AND INDIANA DEPARTMENT OF WORKFORCE DEVELOPMENT, THE PROGRAM PROVIDES PAID, PART-TIME JOB TRAINING IN COMMUNITY SERVICE ASSIGNMENTS.
